Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. **B.** ADDITIONAL COMMENTS TO SUPPORT JD: The area in review contained no waters of the U.S.. All soil samples consisted of Meggett Soils, with little to no moisture throughout the column, and the vegetation are grasses which are mowed and maintained. All indicators onsite point to a well drained, upland site with little to no slope. Horry county NWI data depicts the site as a mixture of U42 (uplands). USGS topographic information and aerial photography depict the site as being an upland area as with no potential wetlands or other WOUS.

This site was assessed on one form.
