C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries are established using the 1987 Wetland Delineation Manual. The site is comprised entirely of Leon and Lynn Haven soils which are hydric throughout their map unit. 2005 Horry County LIDAR data (1ft contour intervals) depict a sharp elevation change in the forested area onsite. Soils throughout the site were 10YR 2/1 with a varying amount of coated or uncoated sand grains. The portion of the site of the lower elevation displayed strong hydrophitic vegetation, hydric soils (a predominance of coated sand grains), and hydrology throughout the wetland area. The wetland area contrasted the upland portion of the site by its lack of hydrology (friable soils, with dominantly uncoated sand grains) and marginally to upland vegetation.

Offsite perennial RPW was found to have evidence of flowing water at least 90% of the year. The tributary had a clearly depicted and well defined OHWM with a pronounced bed and bank system. The channel bottom was firm, clear of any vegetation or debris, and consisted of a mixture of sandy, and gravel (some rocks were approximately 2" in diameter). All indicators point to a tributary with constant flow during a prolonged drought as identified by SCDNR climate data. The tributary discharges directly into the AIWW, located approximately 1800 linear feet downstream. During the site visit, the offsite tributary was observed to have heavy flow draining toward the AIWW. The open channel of the PRPW ends at Pine Bluff Avenue and is conveyed to the AIWW through a storm water pipe with flowing water observed in storm drainage culverts / distribution boxes
