### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD:** This stream is not shown on the topo or soils maps as a line, but the topo does show a signature of the contour lines that represent a topography conducive to the formation of a stream. The channel is a well-defined, continuous bed and bank feature with strong sediment sorting and a sandy bottom in sharp contrast to the mucky banks. The surrounding wetlands provide year-round groundwater input which keeps vegetation and leaf litter cleared from the bed of the stream. Wetland C is bisected by Stream 2 and has uninterrupted flow that connects to the base flow of Stream 2. These wetlands enhance a variety of wildlife species by providing diversity through timber type changes and where aquatic systems adjoin uplands. Due to surrounding land uses, these wetlands act as a catch basin for adjacent uplands, filtering sediment and other pollutants and reducing the release of flood waters to the TNW. The wetlands have the capacity to transfer nutrients and organic carbon that supports downstream foodwebs. The surrounding land use is a mix of large scale residential development with impervious surfaces. Stormwater runoff is attenuated by wetlands, filtering sediments, herbicides, oils, and other petrochemicals from urban runoff, reducing their effects on the downstream TNW. A portion of Knox Lake is within the review area. Knox Lake is an impoundment of Bridge Creek, which is a PRPW. PRPWs and their abutting wetlands are jurisdictional according to RGL 07-01. Therefore, all waters documented on this form are jurisdictional and waters of the United States.
