be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within the wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict wetland symbols where the isolated wetlands were observed in the field. No linear features (i.e. blue lines) were observed in the field or depicted on the topographic maps in the vicinity of the isolated wetlands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict wetland symbols where the isolated wetlands were observed in the field. No linear features (i.e. blue lines) were observed in the field or depicted on the topographic maps in the vicinity of the isolated wetlands.

The isolated wetlands were coordinated with HQ and EPA on 9-8-11.
