### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** One feature shown on the soils map was investigated. Photos 1 and 2 dated September 5, 2011, and narrative submitted by the agent show that there is no channel or feature of any kind in that area. The two wetland areas on the site drain to an unnamed tributary that feeds F. Coopers Pond on Spears Creek. These wetlands enhance a variety of wildlife species by providing diversity through timber type changes and where aquatic systems adjoin uplands. Due to surrounding land uses, these wetlands act as a catch basin for adjacent uplands, filtering sediment and other pollutants and reducing the release of flood waters to the TNW. The wetlands have the capacity to transfer nutrients and organic carbon that supports downstream foodwebs. As PRPWs and their abutting wetlands are jurisdictional according to RGL 07-01, all waters documented on this form are jurisdictional and waters of the United States.
