

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A review of available electronic resources included aerial imagery (including infrared photography), USGS Topo maps, NWI maps, and soils maps was completed prior to the site visit. The site is shown on USGS Quad Maps as forested uplands. On the 1999 infrared aerial photograph, the site appears to be forested and has a heat signature consisted with documented upland forested areas. The 2006 aerial photograph shows that the site as partially forested. The NWI maps depict the site as U42P, uplands and PFO1/3Bd, PFO1/4Ad, wetlands. The soils are mapped as Wagram and Lynchburg (non-hydric) and Rains (hydric) soils. An onsite investigation revealed that no hydrology and no hydric soils were present on the site. A primary successional community was encountered throughout the site which had been clear cut. Hydrophytic vegetation was encountered which does not pass the FAC-neutral test. No linear features or other potentially jurisdictional features were encountered on the site. No waters of the U.S. were encountered on the subject property.
