C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site visit was performed under normal rainfall based on a review of recorded rainfall data for a period of 3 months prior to the site visit. Recorded rainfall for the previous 3 months was 11.23" for this area of Sumter County. A review of NRCS WETS data for Sumter County revealed an upper range of 19.26" with a lower range of 10.84". NRCS WETS data was used to establish normal rainfall. Wetland Area #2 was determined to be directly abutting an offsite tributary that flows to an impoundment which discharges directly into Turkey Creek.

Potential wetlands within the review area consisted of hydrophytic vegetation, and hydric soils, however lacked hydrology. Prior to the site visit, it was determined that precipitation was normal for the months of June, July, and August 2011 totalling 11.23", however, the site contains evidence of hydrologic manipulation (e.g. drainage ditches). For the above listed reasons, the Corps has determined that the three parameters that the define a wetland are not present within these potential wetland areas.

The Project area contains numerous man-made ditches that drain only uplands.

Finally, the project area contains one upland excavated pond. This upland excavated pond was determined not to be associated with any WOUS and therefore not an impoundment of a waters of the U.S.
