C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of jurisdiction established by the mean high water (MHW) / high tide line (HTL) of a tidally influenced creek and adjacent saltwater marsh. Wetlands are subject to the ebb and flow of the tide and is adjacent to a creek (also tidally influenced) that discharges directly into the Atlantic Ocean approximately 2500 linear feet downstream. During the site visit the MHW mark and HTL were observed to be located approximately at the same point due to the steep transition zone from wetlands to uplands. Additionally, all wetlands onsite are within the SCDHEC-OCRM critical area line and are considered to be a TNW due to their tidal influence. These wetlands are separated from the onsite uplands by an abrupt topographic change of 10 feet as identified by Horry County LIDAR 1' elevation contour data. Blue crabs, minnows and other saltwater fauna were observed in the saltwater wetlands onsite.

The tree stratum of the uplands onsite were dominated by mature Mockernut Hickory (*Carya tomentosa*), Live Oak (*Quercus virginianus*), and other marginally facultative or upland species. Soils were mapped as Lakeland, which are listed on the National Hydric Soils List, but were void of any moisture in the soil column. There was a predominance of uncoated sand grains in all of the upland samples, soils were friable and would not remain in the auger after removal. No other indicators of hydrology were present in the upland areas.

No other potentially jurisdictional features were located onsite.
