C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is located just north of Star Bluff Crossroads near Wampee, in Horry County, South Carolina and contains 71.30 acres. Within these 71.30 acres, one freshwater wetland (W-6) was identified and determined to be isolated, non-jurisdictional. In addition, the site contains 2.97 acres of jurisdictional freshwater wetlands (W-1-5) and 2,750 linear feet of tributaries, all of which are documented on basis form 2 of 2.

Wetland "W-6" is completely surrounded by non-hydric soils and no surface or shallow subsurface connection to another water of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. It has been determined that all water contained within this wetland (W-6) is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of

discernable outfall, topography grades, and lack of evidence of chemical or biological connection, this wetland was determined to be isolated non-jurisdictional and not connected to any other water of the U.S.

In addition to the above listed non-jurisdictional isolated freshwater wetland, the project area contains two upland excavated irrigation ponds. Both of these ponds have been excavated from within uplands and were determined not to be impoundments of any WOUS.
