

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Due to the size of the drainage area estimated on both Topographic maps and aerial photos and the fact the USGS topographic maps depict the tributary as a solid blue line feature, the tributary has been determined to have a flow regime of perennial. The offsite tributary was not accessible during field evaluations.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area identified as Wetland 'SSS'' is a freshwater wetland adjacent to an offsite, named (Buffalo Creek) tributary located to the north of the project area. The offsite tributary flows southeast to its confluence with Lynches River, a TNW. The offsite tributary was determined to have a flow regime of perennial by review of USGS topographic maps and aerial photos. Wetland was determined to be directly abutting the offsite tributary by review of aerial photos and topographic maps. Onsite wetland is part of a larger wetland system located offsite that intersects the OHWM of the offsite tributary.
