bulkhead and runs in a northeasterly direction connecting to Wetland B. The culverted bulkhead appears to be connected to a detention basin next to the adjacent parking lot, but the exact extent of the underground system is unknown. The portion of the ditch that runs through the site has no evidence of continuous flow and is a straight channelized ditch most likely dug to drain the surrounding landscape. The ditch eventually transitions into Wetland B in the northeast portion of the site.

### SECTION III: CWA ANALYSIS

This drainage flows to the east underneath the adjacent parking lot, emptying into a detention basin adjacent to Faber Place Drive. This detention basin continues to drain to the east via a culvert underneath Faber Place Drive, emptying into another detention basin that abuts Route 526. At the contact point with Route 526 there is a culvert which allows flow to continue under Route 526 into a straight line daylighted ditch that is culverted underneath Leeds Avenue, continuing underground across the County Detention Center, emptying into yet another detention basin that discharges through culverts into a tidal marsh, ultimately draining into Brickyard Creek which flows directly into the Ashley River.**

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**The wetland on-site (Wetland A) has a drainage feature within that is contiguous with the wetland and drains into a culvert in the northeast corner of the parcel. This drainage flows to the east underneath the adjacent parking lot, emptying into a detention basin adjacent to Faber Place Drive. This detention basin continues to drain to the east via a culvert underneath Faber Place Drive, emptying into another detention basin that abuts Route 526. At the contact point with Route 526 there is a culvert which allows flow to continue under Route 526 into a straight line daylighted ditch that is culverted underneath Leeds Avenue, continuing underground across the County Detention Center parking lot, emptying into yet another detention basin that discharges through culverts into a tidal marsh, ultimately draining into Brickyard Creek which flows directly into the Ashley River.**

**Additionally, Wetland A extends off-site to the north directly abutting a drainage feature which is culverted underneath the adjacent parking lot to the east, becoming daylighted again on the east side of Faber Place Drive before passing through a culvert underneath Route 526. On the east side of Route 526 the culverted drainage becomes daylighted and continues flowing to the east under Tile Drive where it joins with an RPW that is displayed on the USGS map, then passing underneath Leeds Avenue and connecting with Brickyard Creek ultimately emptying into the Ashley River.**
