C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site consists of 0.70 acre of jurisdictional freshwater wetlands that directly abut a perennial RPW (Mill Branch). The wetlands continue offsite to the northeast until they intersect the perennial RPW. The RPW is depicted as a meandering solid blue line on topographic maps and is visible on aerial photography. The tributary was observed as it flows under Hewitt Road. It exhibited characteristics of a perennial RPW to include: bed and banks, hard sandy bottom, OHWM, flowing water, vegetation absent within channel. This site also consists of an open mine pit (10.5 acres) that was determined to be non-jurisdictional.
