If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The system is bisected by the RR track and Lincolnville Road, however manmade berms do not, by definition, break the wetland system. In addition, the connectivity is also maintained through a culvert under the RR tracks south of the site, and another culvert under Lincolnville Road. The unnamed trib and wetland system continue on to where they are contiguous with and abut Spencer Branch. The wetland system and Spencer Branch continue on to Eagle Creek which flows to the Ashley River, a TNW. The on-site wetlands are composed of Rutledge soils, which extend off-site to Portsmouth soils, both of which are hydric. (It is noted that there is a discrepancy between the Map info quad sheet and the Charleston County soil survey book because the county line has changed over time. The soils are listed differently in each county soil survey, however, they are all listed as hydric soils. For purposes of consistency, the Charleston County Soil Survey Book/sheet 22 was used for this determination).**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** It is the determination of this office that the on-site jurisdictional wetlands are headwaters of a larger wetland system that extends off-site, abuts an unnamed blue line stream on the quad sheet and continues on as a contiguous system that flows to and abuts Spencer Branch (RPW) which flows to Eagle Creek (RPW) which flows to the Ashley River, (TNW). The wetland system is visible on aerial photos. This determination was reached through a site visit and review of aerial photos, soil survey information, quad sheets, and NWI.
