portion located south of the project boundary. This depressional wetland is depicted as palustrine emergent surrounded by uplands (U21) on the NWIs and as Coxville-Rains, a hydric soil, surrounded by Alaga, which is non-hydric, on the soil survey. During the site visit, a non-jurisdictional ditch was observed near the eastern boundary of the wetland; however, this ditch terminates in uplands east of the project boundary at St. Paul's Church Road with no culvert or other connection to any other potential WOUS. This man-made ditch was determined to have less than seasonal flow based on the presence of trees and other terrestrial vegetation growing in the bottom and a lack of OHWM. The western end of this ditch is located immediately east of the on-site wetland but does not intersect with the on-site wetland boundary. The entire wetland boundary (on and off site) was viewed during the site visit, and this depressional wetland was determined to be completely surrounded by uplands with no surface or subsurface connection to other waters of the US. Therefore, this wetland was determined to be an isolated, non-jurisdictional wetland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
