Explain: **A man-made ditch was evaluated during the site visit. The ditch carried stormwater from across the road into Lake Wateree. The area had received 9 inches of rain during the week of the site visit, so the ditch was flowing.**

Due to the flow in the ditch, it was not possible to take a soil sample in the ditch. A soil sample was taken immediately adjacent to the ditch, and it did not contain any hydric soil indicators. The ditch appeared to have been constructed in uplands. The ditch exhibited scour, absence of vegetation, and leaf litter had been washed away. However, these characteristics were present due to the temporary flow of stormwater through the ditch in response to rain events. The ditch does not exhibit an ordinary high water mark associated with relatively permanent flow under normal circumstances. A review of the information gathered on site, information provided by the owner, and a review of topographic maps, aerial photography, soil survey information, and NWI maps gives no indication that the ditch drains other waters of the U.S. The ditch appears to drain only uplands. Since the ditch was constructed in uplands, only drains uplands, does not have relatively permanent flow, and does not have an ordinary high water mark associated with relatively permanent flow under normal circumstances, it is not considered a tributary and it is not jurisdictional under section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A man-made ditch was evaluated during the site visit. The ditch carried stormwater from across the road into Lake Wateree. The area had received 9 inches of rain during the week of the site visit, so the ditch was flowing. Due to the flow in the ditch, it was not possible to take a soil sample in the ditch. A soil sample was taken immediately adjacent to the ditch, and it did not contain any hydric soil indicators. The ditch appeared to have been constructed in uplands. The ditch exhibited scour, absence of vegetation, and leaf litter had been washed away. However, these characteristics were present due to the temporary flow of stormwater through the ditch in response to rain events. The ditch does not exhibit an ordinary high water mark associated with relatively permanent flow under normal circumstances. A review of the information gathered on site, information provided by the owner, and a review of topographic maps, aerial photography, soil survey information, and NWI maps gives no indication that the ditch drains other waters of the U.S. The ditch appears to drain only uplands. Since the ditch was constructed in uplands, only drains uplands, does not have relatively permanent flow, and does not have an ordinary high water mark associated with relatively permanent flow under normal circumstances, it is not considered a tributary and it is not jurisdictional under section 404 of the Clean Water Act.
