This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 8.67 acre property, comprised of three different tracts, was determined to have no wetlands or other waters of the US present based on a review of the aerials, topographic map, and NWIs. The aerials and topographic map depict a developed lot with no wetlands or other waters of the US. A review of the 1970 aerials depicted in the Sumter Co. Soil Survey also depict the majority of this property as developed. The NWIs depict this site as uplands (U12). The soil survey depicts this area as Rains, which is a hydric soil; however, the previously developed site consists of a commercial building that was constructed prior to 1999, according to the aerials. Therefore, this site was determined to consist entirely of uplands.
