The wetlands on-site continue off site to the north and then to the east as a wetland/drainage system (Huckhole Swamp/Goose Creek) that is evident on aerial imagery, depicted on the NWI Map, and displays continuous hydric soils to where the system drains into the Goose Creek Reservoir (Section 10 Water of the US), connects to the Cooper River (Section 10 Water of the US) and ultimately drains into the Atlantic Ocean. In addition, the wetlands on-site also continue off-site and directly abut a perennial RPW that is part of the same contiguous wetland system, as discussed in III D. 2 & 4.**

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: **Photos taken on the 9/20/12 site visit depict flowing water along the reach within and just outside of the investigation area with water depths ranging from several inches in the headwaters to several feet in pools. According to the NOAA National Weather Forecast Summary for the month of September 2012, the monthly average precipitation for North Charleston was 4.08 inches less than the normal average for that month. Additionally, prior to the September 20 site visit; there was only a total of 1.1 inches of precipitation during the month of September with rain events of 0.94” on September 7, 0.01” on September 8, and 0.15” on September 18. The stream substrate consists of silt, sand and gravel with clear bed and banks, riffle-pool features, depositional areas, sinuosity, and a rather large floodplain with drift deposits over 40 feet from the stream bank which in some parts is approximately 4 feet higher than the stream bottom. Fish were observed in both the headwaters portion of the RPW as well as the pool displayed in the photographs. The drainage area for this stream is approximately 155 acres. It has been influenced by man and receives the majority of the storm water runoff from Charleston Southern University. Pre-development, the USGS map topographic contours display lower topography in this area and evidence of water conveyance or a potential drainage feature. The stream was most likely manipulated or rerouted slightly during University construction. There are currently two detention basins and a drainage ditch upstream from the site in line with where the USGS topography suggests water was directed. LIDAR for Charleston County depicts the stream from its origin, flowing through the site wetlands at an off-site location, connecting to the Huckhole Swamp/Goose Creek wetland system. Additionally the Charleston County Soil Survey depicts hydric soils along the stream corridor and USGS depression zone. Based on the mentioned on and off-site information, the tributary was determined to be a Perennial RPW.**

The wetlands on-site continue off site to the north and then to the east as a wetland/drainage system (Huckhole Swamp/Goose Creek) that is evident on aerial imagery, depicted on the NWI Map, and displays continuous hydric soils to where the system drains into the Goose Creek Reservoir (Section 10 Water of the US), connects to the Cooper River (Section 10 Water of the US) and ultimately drains into the Atlantic Ocean.
