This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

It should be noted that the presence of a road crossing does not sever the jurisdictional connection.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Three jurisdictional wetlands were found on the subject property totaling 0.879 acres. Wetland 3 directly borders the north side of the unnamed RPW. Wetlands 1 and 2 are part of the same wetland that originally bordered the unnamed RPW and is shown as a single hydric soil unit (Grifton). Wetlands 1 and 2 are now separated from the RPW by fill (road crossing) as a result of permit SAC 39-2005-2192 and the construction of a 30 foot sewer and water right-of-way and pump station constructed by the Commissioners of Public Works of the Town of Summerville.
