The wetland is located in the bed of an upland dug pond that has been drained. Corps personel walked around the entire wetland and dtermined that the water does not flow anywhere, but sits in hthe bed of the historically upland dug pond. The wetland was determined to have no biological, chemical, physical, or ecological connection to Waters of the U.S..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site includes 0.3770 acre of a 0.4075 acre isolated, non-jurisdictional palustrine, depressional wetland. The wetland is located in the bed of an upland dug pond that has been drained. Corps personel walked around the entire wetland and dtermined that the water does not flow anywhere, but sits in hthe bed of the historically upland dug pond. The

wetland was determined to have no biological, chemical, physical, or ecological connection to Waters of the U.S. This office has determined that the isolated wetland documented in Section III Part F of this form has no physical, chemical, or biological connection to waters of the U.S., including any apparent surface or shallow subsurface hydrologic connection.

There is no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. On this basis, this office has determined that this wetland is isolated from waters of the U.S. and is not within the jurisdiction of the Clean Water Act
