Explain: **The site has 2 isolated wetlands (E=0.082 acres and I=0.041 acres). Wetland E is a depressional area on a hill that does not have any connections or signs of flow outside of the area. This area is completely surrounded by uplands and is not adjacent to a tributary. There are ruts in the wetland and some in the upland areas surrounding the**

wetland, but these ruts disappear and lead to nothing. Wetland I is a depression area in a part of the site that shows an intermittent stream on the soil survey. This stream is not there. There is a small swale entering and leaving the wetland, but this swale loses its form and does not connect to anything. This area is completely surrounded by uplands and the nearest jurisdictional water appears to be over 500 feet away. There is no evidence of overland sheetflow or any drainage connections leaving the wetlands. Wetlands E & I have no connection to a jurisdictional water of the U.S. These wetlands have no physical, chemical, or biological connection to waters of the U.S., including any apparent surface or shallow subsurface hydrologic connection. There is no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetlands and waters of the U.S.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

that shows an intermittent stream on the soil survey. This stream is not there. There is a small swale entering and leaving the wetland, but this swale loses its form and does not connect to anything. This area is completely surrounded by uplands and the nearest jurisdictional water appears to be over 500 feet away. There is no evidence of overland sheetflow or any drainage connections leaving the wetlands. Wetlands E & I have no connection to a jurisdictional water of the U.S. These wetlands have no physical, chemical, or biological connection to waters of the U.S., including any apparent surface or shallow subsurface hydrologic connection. There is no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetlands and waters of the U.S. On this basis, this office has determined that this wetland is isolated from waters of the U.S. and is not within the jurisdiction of the Clean Water Act.
