Summarize overall biological, chemical and physical functions being performed: Wetlands evaluated in this significant nexus determination whch are similarly situated and adjacent (both directly abutting and non-abutting) to the RPW are collectively performing biological, chemical, and physical functions. They provide habitat and breeding grounds for aquatic species in an area where the tributaries and wetlands have been altered. These wetlands also help to filter nutrients and pollutants from nearby roads and industry before they travel to the downstream RPW and TNW. These wetlands provide flood storage during times of heavy rain and the wetter months.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
