C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Tributaries of TNWs where tributaries typically flow year-round are jurisdictional. Provide data and rationale indicating that tributary is perennial: The tributary was observed to have flowing water and a strong and continuous OHWM with defined bed and bank, a firm sandy bottom free of vegetation, mid channel bars, and strong sediment sorting. The tributary hydrologic indicators were the open channel with evenly distributed substrates and water bars where leaves and debris are washed downstream by the constant flowing water even under drought conditions. A review of aerial photography shows a defined channel. Spartanburg County Soil Survey, depicts named stream Big Shoally Creek as a third order. USGS depicts a named Big Shoally Creek second order, blue line stream. This tributary is a PRPW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form documents the subject PRPW and abutting wetlands. This tributary, a PRPW, and its abutting wetland provide important biological, chemical, and physical functions that support the integrity of the downstream TNW. The wetland enhances a variety of wildlife species by providing diversity through vegetation and substrate changes and where the aquatic system adjoins the uplands. The wetland acts as a catch basin for adjacent uplands, filtering sediment and other pollutants and reducing the release of flood waters to the downstream TNW. The tributary through its cruvature and sinuosity further retains and reduces the velocity of flood waters from the drainage area. Bacteria and aquatic insect larvae in the tributary and the wetland consume organic materials and convert nutrients from the adjacent uplands. The tributary and wetland transfer nutrients and organic carbon that support downstream foodwebs. The tributary also transports sediment and other pollutants from the drainage area to the downstream TNW. As such, this tributary and wetland have a significant nexus with the TNW and are jurisdictional. RPWs and their abutting wetlands are jurisdictional according to RGL 07-01. Therefore, all waters documented on this form are jurisdictional waters of the United States.
