This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Biological- the tributary provides shelter, habitat, and breeding grounds for aquatic life. The tributary also provides biological benefits for local fauna such as a source of drinking water and shelter. Chemical- the drainage area of the UT consists of a residential subdivision and agriculture land. The tributary receives stormwater from the subdivision and agriculture land. The tributary filters and retains pollutants in sediments that settle out in the channel and reduce the amount of pollutants that are carried downstream and ultimately into Fishing Creek Reservoir (TNW). The tributary provides physical functions that include reducing the velocity of flood waters ultimately flowing in to the TNW. The tributary helps to maintain normal downstream flows. The UT of Tools Fork Creek has a significant nexus with Fishing Creek Reservoir (TNW).

B. ADDITIONAL COMMENTS TO SUPPORT JD:
