C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This document concerns the jurisdictional status of waters of the United States, including wetlands, located within the 2.1497 acre "Lot D" that is adjacent and south of Morris Bing Road, approximately one mile east of SC 174, near the Town of Adams Run, Charleston County, South Carolina.

This 2.1497 acre lot was subdivided from a much larger lot identified by the TMS # 096-00-00-030. "Lot D" contains no waters of the United States or wetlands. Corps personnel inspected the site on September 6, 2012. Soil was an upland sandy soil mixture of salt and pepper and did not contain signs of wetland hydrology. Lot D is located on an upland shelf relative to the wetlands located to the south of the property. The topographic maps show a steep 10 feet incline between the border of Lot D and the adjacent wetlands south of the property. Soil survey maps indicate that the soil is moderately well drained (wando loamy fine sand). NWI maps did not show wetlands located on the property. Based on this information, it is determined that no waters of the United States or wetlands are located on the property site and that this 2.1497 acre lot is not subject to Clean Water Act jurisdiction.
