#### Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be

**not jurisdictional. Explain:** The project area contains a 0.369 acre isolated wetland. The wetland is a small depressional area located in a low point within a power line right-of-way. The topo map depicts an intermittent blue line stream approximately 700 feet away, however this feature is not a tributary, it is a linear storm water conveyance feature that does not exhibit an OHWM. The linear feature and wetland are located in previously disturbed areas due to past impacts from SCE&G utilities and infrastructure. This office has determined that the wetland is isolated and has no physical, chemical, or biological connection to waters of the U.S., including any apparent surface or shallow

subsurface hydrologic connection. There is also no apparent connection to interstate or foreign commerce. #### C. SIGNIFICANT NEXUS DETERMINATION
