C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of the jurisdiction of wetlands were determined using remote sensing procedures. No site visit was performed. All available aerial photographs depict the site as an agricultural field with a drainage feature on the east property boundary. Soil surveys depict the site as non-hydric soils (Dunbar, Marlboro), soils with hydric inclusions (Lynchburg and Norfolk), and hydric soils (Coxville). All of these areas are heavily manipulated by the agricultural operation and have been drained by existing linear drainage features. Two man-made linear features was observed on aerial photographs within the review area. The features are not depicted on the USGS Topo Quad Maps and no wetlands are identified on the NWI maps connected to this reach or the upstream reach of these features. The entire property and the reaches of these features are consistent with an upland heat signature on the infrared aerial photography. All evidence shows that the existing linear features are excavated out of uplands and draining only uplands. The features were determined to be non-jurisdictional ditches. No other potentially jurisdictional features were observed within the review area.
