C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Other information (please specify): **Water Runoff Study For Main Drainageways and Outlets Georgetown County, South Carolina, dated June 1979. A review of the Study revealed no drainageways in close proximity to delineated wetland. Sheet 9 of the study depicts the closet drainage as M3A located approximately 2,200 linear feet due north of the delineated wetland crossing under Waverly Road flowing east then north and outfalling into the Waccamaw River.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: **The project area is located adjacent to and northwest of U.S. Highway 17 in the Township of Pawleys Island, Georgetown County, South Carolina and contains approximately 25 acres. Within these 25 acres, one 2.0 acre freshwater wetland was identified and determined to be isolated, non-jurisdictional wetland. In addition, the project area contains two (2) upland excavated stormwater ponds located adjacent to U.S. Highway 17.**

The onsite wetland is completely surrounded by non-hydric soils and no surface or shallow subsurface connection to another water of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, GT Drainage Study of 1979, and topographic maps. The entire perimeter of the wetland was observed in the field. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated non-jurisdictional and not connected to any other water of the U.S. The closet verified OHWM of any tributary to the delineated wetland is located approximately 1,800 linear feet to the southeast. The site is surrounded by commercial and residential developments.

The onsite wetland consists of a forested topographic depression with no direct surface connection to any waters of the United States (WOUS). Topographic contour mapping as well as the field evaluation of August 10, 2012 indicates the depression is confined and completely surrounded by uplands. The closet OHWM of a WOUS is located approximately 1,800 linear feet to the southeast and 1,030 linear feet due west.
