C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This document concerns the jurisdictional status of waters of the United States, including wetlands, located on the combined 1.94 acre lot 39, Smithville subdivision, north and adjacent to the intersection of Venning Rd & Halls Pond Rd, Charleston County, South Carolina.

No waters of the United States or wetlands were found within the aforementioned property during a Corps on-site inspection dated August 28, 2012. This 1.94 acre lot is located within the City of Mt. Pleasant and is surrounded by residential development. Hydric soils and hydric vegetation were found throughout portions of the property, yet these locations did not contain the necessary hydrology requirement that defines a wetland. Local ditching abutting the south and west end of the property keeps the required water table and hydrologic conditions necessary for a wetland to be absent. The Charleston soil survey maps indicate that the property is dominated by partially hydric map units (Wando loamy fine sand, Kiawah loamy fine sand). No wetlands or waters are located on the property according to the National Wetlands Inventory. There are no waters of the United States or wetlands located on this property, and as such, this property does not fall under Section 404 Army Corps of Engineers jurisdiction.
