SUBJECT: 2000 Pribilof Islands Subsistence Fur Seal  
Harvest - Final Report

Subsistence harvesting of northern fur seals was conducted on St. Paul Island for 15 days between July 5, 2000 and August 8, 2000 and on St. George Island for 11 days between June 5 and August 8. A total of 754 seals were taken on St. Paul Island during the 2000 season and 121 seals were taken this year on St. George Island. The combined total number of seals taken in the 2000 subsistence harvest was 875. Please see the attached tables for specific details.

#### St. Paul Island

By prior agreement with the Tribal Government of St. Paul Island only whole carcasses were removed from the field.

The annual Community Development Quota (CDQ) local fishery for halibut, which occurs during the same time of the year as the subsistence harvest on the Pribilofs, created significant time conflicts for the St. Paul Island sealing crew. Many of the experienced sealers are involved with the CDQ fishery upon which they depend for a large part of their annual income. The lack of experienced sealers available to participate in the harvest caused significant delays in beginning many of the harvest events such that none of these events were able to begin before 11 a.m. The environmental conditions during several harvest days were such that a total of 4 seals died of heatstroke during the 2000 harvest season, the meat of which was not taken.

As the appearance of young female seals mixing with non-breeding male seals on the haulout areas occurred somewhat earlier this year than usual, 1 female seal was accidentally killed on St. Paul Island during the 2000 harvest, the meat was not taken.

There were 4 bull seals accidentally struck/injured and 1 bull seal was accidentally struck and killed, the meat of which was not taken.



A minimum of 5 seals were disentangled from marine debris (primarily trawl net and packing bands) during the harvest and released in good condition.

There was a significant problem regarding the amount of waste during the 2000 harvest. In addition to those mortalities resulting from heatstroke and accidentally, the carcass dump and other areas were monitored daily where a minimum of 8 seals taken during the harvest were observed to have been discarded with only the front flippers removed. The number of seals directly observed to have been wasted totaled 15.

As a result of this level of waste, a temporary halt to the harvest on St. Paul Island was imposed from July 24 through July 31 during which time the problems contributing to the high level of waste were identified and discussed. Individuals thought to be responsible for discarding edible seal meat were contacted and admonished by representatives from the Tribal Government and the harvest foreman. The St. Paul harvest was resumed without further incident on August 1 and terminated on August 8 as per regulations at 50 CFR 216.72(3)(f).

#### **St. George Island**

There was 1 incident of heatstroke on St. George Island during the 2000 harvest of which the meat was not taken. No female seals or any bull seals were accidentally struck.

Only whole carcasses were removed from the field. A total of 25 rib sections were not removed from the field during the 2000 harvest season on St. George. However, this constitutes a very small portion of the total amount of edible meat available from each animal and is not regarded as significant.

#### **Both Islands**

A moderate amount of edible parts not required to be utilized such as stomachs, kidneys and blubber were also taken on both islands, as were some inedible parts such as throats, pelts, teeth and bone for use in traditional arts and handicrafts as permitted by regulation.

The carcass dumps on both islands were monitored daily by NMFS monitors. No bacula were observed to have been removed from any seals taken in the harvest on either island.

A certified veterinary pathologist served as the Humane Observer on St. Paul Island and NMFS staff monitored the daily harvests on both islands. Other than the incidents occurring on St. Paul described above, there were no significant problems with the 2000 harvest and for the most part, it was conducted within the regulations at 50 CFR 216 Subpart F.
