Proposed Action or Project Description:

American Recovery and Reinvestment Act:

Funding will support laboratory and bench scale research and development on nanostructured, millimeter-scale, thick film magnetic materials toward the development of advanced magnetic cores. The proposed work is consistent with the goal of ADEPT: fundamental advances in soft magnetics, high voltage switches, and reliable, high-density charge storage.

Proposed work consists entirely of RD&D work to be completed at GE Global Research's Niksayuna, NY research and fabrication facility; and Dartmouth's Hanover, NH research and fabrication facility. The work performed will be limited to in-lab design, analysis, and development.
