Proposed Action Title: Cree, Inc. - 15kV SiC IGBT Power Modules for Grid Scale Power Conversion

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Research Triangle Park, NC; Raleigh, NC; Youngwood, PA

Proposed Action Description:

Funding will support efforts to develop packaging for Cree's current research efforts under the original ARPA-E award focused on the development of a highly efficient, transformerless, intelligent power substation (TIPS). The packaging effort will enable the device currently developed by Cree to support reliable high temperature operation.

Proposed work will consist of: (1) development of a low-inductance, double-side cooled, failshort, compression-bonded 15 kV/250 ASiC IGBT Half H-Bridge prototype device and (2) designing, modeling, and testing of the prototype device to ensure it meets established performance objectives.

Development of the prototype device will take place at Powerex, Inc.'s facility in Youngwood, PA. Design, modeling, and testing of the prototype device will take place at Northern Carolina State University's laboratory facilities in Raleigh, NC.

Proposed Action or Project Description:

American Recovery and Reinvestment Act:

Funding will support laboratory-scale research and development activities to verify proof-of-concept for advanced transistor based electrical substations that can help make the electrical grid more flexible and controllable. The proposed work is consistent with the goal of ADEPT: fundamental advances in soft magnetics, high voltage switches, and reliable, high-density charge storage.

Proposed work consists entirely of RD&D work to be completed in laboratories and facilities at Cree's headquarters in Durham, NC; North Carolina State University's campus in Raleigh, NC; Powerex's facilities in Youngwood, PA; the Naval Research Laboratory in Washington, D.C.; and ABB's computational facilities in Raleigh, North Carolina. The work performed will be limited to in-lab design, fabrication, testing, and analysis.

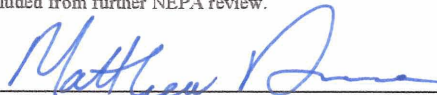
