Funding will support laboratory and bench scale research and development on dramatic improvements in three technological limiting areas of power electronics devices; semiconductor devices, magnetics, and circuit architectures. The proposed work is consistent with the goal of ADEPT: fundamental advances in soft magnetics, high voltage switches, and reliable, high-density charge storage,

Proposed work consists entirely of RD&D work to be completed in design, fabrication, and testing facilities on the campuses of the Massachusetts Institute of Technology, Dartmouth College, the Georgia Institute of Technology, Pennsylvania State University, and the facilities of the OnChip corporation. The work performed is entirely limited to in-lab design, analysis, and development.
