Proposed Action Title: (0474-1580) SolarBridge Tech - Scalable Submodule Power Conversion Methods for Power Density, Efficiency, Performance, and Protection Leaps in Utility-Scale Photovoltaics

Proposed Action Description:

Funding will support the development of a unique power electronics architecture aimed at combining vital local power optimization control in a modular power electronics architecture with efficient direct conversion in a string system. This architecture targets mismatched module power only, resulting in (1) significant reductions in overall system cost and (2) increases in system efficiency.

Proposed work will consist of indoor design, fabrication and analysis and minor, controlled outdoor testing activities to accomplish the following: (1) comprehensive proof-of-concept analysis; (2) dynamic performance behavior modeling and analysis; (3) design of diagnostics and communication systems; and (4) reliability and long-term energy yield modeling and analysis.

Primary design, optimization, fabrication, testing (both indoor and on a limited rooftop photovoltaic array installed for this project), and analysis will occur at the SolarBridge facilities in Austin, TX; design consulting and analytical assistance will occur at the University of Urbana-Champaign laboratories in Urbana, IL; and photovoltaic arrays outfitted with the proposed module will be tested at three commercial photovoltaic outdoor testing sites in Phoenix, AZ, Flagstaff, AZ, and Miami, FL.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
