<u>Proposed Action Title</u>: (0474-1602) Carnegie Mellon University - Nanocomposite Magnet Technology for High Frequency MW Scale Power Converters

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Pittsburgh, PA; Wright Patterson Air Force Base, OH; Los Alamos, NM

Proposed Action Description:

Funding will support the development of a new nanoscale magnetic material for energy conversion systems with direct grid connection. The magnetic material will reduce the size, weight, and materials cost associated with the power conversion system. It will also contribute to efficient, cost-effective, and reliable grid integration of solar photovoltaics.

Proposed work will consist of: (1) alloy development, processes for optimizing anisotropy, and reliability measures; (2) examination of the performance of various developed alloys at pilot scale fabrication levels; and (3) pilot-scale prototype production for intensive testing, observation, modification (if necessary) and analysis.

Proposed work will take place at Carnegie Mellon University Laboratories in Pittsburgh, PA; Wright Patterson Air Force Base in Ohio; the laboratories of Magnetics, a division of Spang, in Pittsburgh, PA; and at laboratory facilities at Los Alamos National Laboratory in Los Alamos, NM. Limited analytical paper studies will occur at the University of Pittsburgh in Pittsburgh, PA.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
