4. REQUESTED CHANGE: [NOTE: Significant changes from PDC 1016 are highlighted throughout.]

a. **Brief Overview of Change:** Add a new Disposition Services Indicator value of CPBV (Controlled Property **Branch** Verified **as Not Controlled**) for use with DLMS 527R Receipt transaction to satisfy DLA Disposition Services business requirements.

b. **Background:** The DLA Disposition Services is a worldwide presence within the Department of Defense, with disposal specialists in 14 foreign countries, two U.S. territories, and 39 states. DLA Disposition Services' mission is the execution of disposition solutions for excess military property. The RBI project will replace the Defense Reutilization and Marketing Services (DRMS) Automated Information System (DAISY) by integrating DLA Disposition Services business processes within the DLA enterprise suite of applications, including the Enterprise Business System (EBS) for materiel management functions and the Distribution Standard System (DSS) for warehousing/distribution functions.

c. Describe Requested Change in Detail:

(1) Add new Disposition Services Indicator value 'CPBV- Controlled Property Branch Verified as Not Controlled' as shown in paragraph 9.b., to the existing Disposition Services Indicators. The existing indicators used with the DLMS 527R Receipt transaction are outlined in the ADC 442 Disposition Services Indicators Table.

(2) By adding the additional Disposition Services Indicator value CPBV for use with the DLMS 527R Receipt, the DLA Disposition Services Inventory Control Point (ICP) (which uses EBS) will send the information required to properly receipt property, complete all validations required, post the inventory, and then complete post-receipt activities such as writing the record to the reimbursement table and disposing of the asset as necessary. As outlined in ADC 442 (reference 3.a.), when property identified to a Disposal Turn-In Document (DTID) number is turned in, it is assigned a disposition category. This disposition category is used to determine what should happen to the property after receipt. In order to determine disposition category, or confirm the disposition category in the case where the category was assigned at the time of turn-in due to the disposition interface not being operational, many different characteristics of the property must be considered. There are many characteristics currently outlined in ADC 442 that are sent to EBS on the receipt, but a characteristic for Controlled Property Branch Verified as Not Controlled is currently not present and must be added to satisfy DLA Disposition Services business requirements.

d. Revisions to Defense Logistics Manual (DLM) 4000.25 Manuals:

(1) Revise DLMS Supplement 527R as noted in Enclosure 1.

(2) Revise DLM 4000.25, Volume 2, Chapter 16, as shown in Enclosure 2.

e. **Approved Transaction Flow:** No new transactions or routing rules are required.

f. **Alternatives:** None available at this time.

5. REASON FOR CHANGE: To support DLA Disposition Services requirement for receipt processing under RBI.

6. ADVANTAGES AND DISADVANTAGES:

a. **Advantages:** DLA Disposition Services (using EBS and DSS), will be able to comply with DLMS standards for the RBI process as well as meeting DLA Disposition Services business requirements.

b. **Disadvantages:** Updating the 527R transaction will require coding changes in the RBI system suite (including DSS and EBS) to accommodate the mapping and processing of the new Disposition Services Indicator of CPBV.

7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET: Target implementation date is August 27, 2012.

8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE: N/A

9. IMPACT:

a. **New DLMS Data Elements:** None.

b. **Changes to DLMS Data Elements:** Update the DLMS Data Dictionary to add a new value to the existing Disposition Services Indicator. Disposition Services Indicator is a DLMS Data Dictionary code list added by previous ADCs to support DLA Disposition Services under RBI. The indicator addresses the DLA Disposition Services’ requirement to communicate unique property and/or materiel location information supporting their business processes. LQ/1270 Qualifier ‘DSI-Disposition Services Indicator’ is used. The following Disposition Services Indicator value for use with 527R Receipt is added:

Disposition Services Indicator	Explanation	Description
CPBV	Controlled Property Branch Verified as Not Controlled.	Identifies that the disposition services Controlled Property Branch has verified that a local stock number (LSN) originally deemed controlled by EBS business rules and not safe for general release has been verified as not controlled. Reasons include that the LSN has: <ul style="list-style-type: none"> a) been deemed safe for release by a DLA Disposition Services field site approved user, b) been downgraded at receipt, and therefore is no longer usable property, or c) an accurate FLIS stock number found to use for the receipt.

c. **DLMS Transaction:** Revises DLMS Supplement 527R as shown in Enclosure 1.

d. **Automated Information Systems (AIS):** Impacts DLA AIS only. DLA EBS and DSS will require coding changes to properly map and process the new Disposition Services Indicator value.

e. **DLA Transaction Services:** Update DLA Transaction Services mapping as needed for the new Disposition Services Indicator value of CPBV for use with DLMS 527R Receipt.

Revise DLM 4000.25-M, DLMS, Volume 2, Chapter 16, Disposition Services, as revised by ADC 442 (change identified by *red, bold, italics*):¹

1. **Revise paragraph C16.6.7.2.**, to include ‘CPBV’ in the disposition services indicators listed in the paragraph.

“C16.6.7.2. DLMS 527R Required Data Elements. The DLMS 527R Receipt transaction includes the following data elements as applicable to support the disposition category code assignment process and to subsequently track other disposal processes: Bill to DoDAAC, DEMIL code, demilitarization integrity code, demilitarization performed code, disposition services accumulation number, disposition category code, disposition services container ID, disposition services complete container count, disposition services current container count, disposition services indicator: Abandoned Property (AP) Indicator, Certificate (CA) Indicator, ***Controlled Property Branch Verified as Not Controlled (CPBV)***, DEMIL Instructions (DI) Indicator, HM Indicator, HW Indicator, or HWPS Indicator, Receipt-In-Place (RIP) Indicator, SA/LW Indicator; Wash Post (WP) Indicator, disposition services reimbursement code, disposition services UCN, DTID number or DTID number and suffix, DTID materiel description, hazardous materiel indicator code, Industrial Plant Equipment (IPE) report number, MSDS Number, model number (used only in conjunction with IPE Report Number), Sales Contract Number, Sales Contract Line Item Number, Service LSN, year of manufacturer (used only in conjunction with IPE Report Number).

2. **Revise paragraph C16.6.7.6**, to add new subparagraph C16.6.7.6.3., for Disposition Services Indicator CPBV. Renumber remaining subparagraphs C16.6.7.6.4 through C16.6.7.6.9 as C16.6.7.6.5 through C16.6.7.6.10:

“C16.6.7.6. Disposition Services Indicator. The field office shall assign a disposition services indicator in the DLMS 527R Receipt transaction to communicate unique property and/or materiel location information as follows:

C16.6.7.6.1. AP – Abandoned Property

C16.6.7.6.2. CA – Certificate Available to Document Property Condition

C16.6.7.6.3. CPBV – Controlled Property Branch Verified as Not Controlled.”
