

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

a) Pursuant to Contract Clause 1.8 (FAR 52.217-9), "Option to Extend the Term of Contract," this modification exercises the Government's right to extend the contract period of performance from November 1, 2006, through October 31, 2007. The current total of obligated funds under this contract remains unchanged at \$6,179,575.89.

b) Contract Option No. 1 (Nov. 1, 2006 through October 31, 2007) increases the total contract value by \$1,857,336.20, from \$5,572,008.60 to \$7,429,344.80.
