

SUBJECT: Approved DLMS Change (ADC) 68, Revision to DLMS Supplement (DS) 527R,
Receipt, Inquiry, Response and MRA (Supply) to Incorporate Standard Notes

This revision to the DoD 4000.25-M, Defense Logistics Management System (DLMS), modifies the DS 527R Receipt, Inquiry, Response and MRA. These changes include administrative updates to several DLMS notes for desired clarification and consistency with other DLMS supplements and will be incorporated in the DS 527R along with Approved DLMS Change 51.

The updated DLMS Supplement will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlms/ICs/Default.htm>) within 30 days from the above date for implementation planning. DLMSO will concurrently pursue coordination/approval with the DoD Logistics Functional Working Group, the DoD Electronic Data Interchange Standards Management Committee (EDISM), and the Federal EDI Standards Management Coordinating Committee (FESMCC) for Federal implementation conventions (IC) revisions.
