

SUBJECT: Approved DLMS Change 72, Revision to DLMS Supplement (DS) 527R,
Receipt, Inquiry, Response and MRA, DLMS Business Rules Clarification

This change to the DoD 4000.25-M, Defense Logistics Management System (DLMS), reflects administrative changes to the DS 527R necessary to clarify use of various data elements and segments. These changes are consistent with changes agreed to for DS 527D as documented in ADC 54, Revision to DLMS Supplement (DS) 527D, Due-In/Advance Receipt/Due Verification. This change is required to support continued operations in a DLMS/DLSS environment. **The updated DLMS Supplement will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlms/ICs/Default.htm>) within 15 days from the above date for implementation planning.**

3. REQUESTED CHANGE:

a. Title: Revision to DS 527R, Receipt, Inquiry, Response and MRA, DLMS Business Rules Clarification

b. Description of Change: This change modifies DS 527R to make various changes administrative changes to DLMS notes consistent with the associated changes made for the 527D, after an in-depth review of DS 527D by the Supply Process Review Committee (SPRC) at SPRC Meeting 02-1, January 15-18, 2002. The 527D changes are documented in ADC 54, Revision to DLMS Supplement (DS) 527D, Due-In/Advance Receipt/Due Verification.

c. Procedures: Revise DS 527R as indicated in the enclosure.

d. Alternatives: None identified.

4. REASON FOR CHANGE: Administrative note changes necessary for clarification as identified in the enclosure.

5. ADVANTAGES AND DISADVANTAGES:

a. Advantages: Supports DLMS implementation.

b. Disadvantages: None identified.
