

SUBJECT: Approved Defense Logistics Management System (DLMS) Change (ADC) 151, Administrative Revisions to DLMS Supplement 846L, Logistics Asset Support and 846S, Logistics Reassignment Storage Transfer/Order/Reply (Supply)
