3. REQUESTED CHANGE:

a. Title: ADC 161, Administrative Revision to DS 945A, Material Release Advice, to add Advice Code

b. Description of Change: This revision corrects the 945A DS by adding missing qualifier to identify the Advice Code. Advice Code is present in the equivalent MILSTRIP format for A6_, Material Release Denial, but was inadvertently dropped from the DLMS format.

c. Procedures: Revise 945A DLMS Supplement as follows:
