**4. REQUESTED CHANGE(S):** Significant revisions subsequent to staffing are highlighted in green.

a. **Brief Overview of Change:** Due to the unique situation present with confiscated or foreign captured weapons and the effort required to create a Materiel Master within DLA's

Enterprise Business System (EBS), this DLMS change is required to allow for two Stock Numbers (one being the DOD SA/LW Serialization Program authoritative LOGSA-generated Management Control Number (MCN) and the other being the EBS Materiel Master Disposition Local Stock Number (LSN) for Small Arms) to be passed on the materiel receipt and to identify which stock number is the LOGSA-generated MCN and which is the Disposition LSN. This ADC similarly applies the LOGSA-generated MCN and Disposition LSN to the DLMS supplements that the DLA Disposition Services Field Office will use to apprise DLA Disposition Services as these weapons process through to demilitarization. **The Disposition LSN is only for DLA internal purposes, and is not used in lieu of the MCN.**

**b. Background:** The DLA Disposition Services is a worldwide presence within the Department of Defense, with disposal specialists in 14 foreign countries, two U.S. territories, and 39 states. DLA Disposition Services' mission is the execution of disposition solutions for excess military property. The RBI project will replace the Defense Reutilization and Marketing Service (DRMS) Automated Information System (DAISY) by integrating DLA Disposition Services business processes within the DLA enterprise suite of applications, including EBS for materiel management functions and Distribution Standard System (DSS) for warehousing/distribution functions.

DLA Disposition Services requires that the subject transactions send a Disposition LSN for communications between DSS and EBS in addition to the LOGSA generated MCN for confiscated or foreign captured weapons. This requires that both identifying numbers (LOGSA generated MCN and the Disposition LSN) be carried on the DLMS transactions for RBI and that the transactions be modified to allow for a notation that will specify which stock number is which. For non-Small Arms property, these transactions carry the NSN or an agreed upon Disposition LSN that identifies the property in DSS and EBS. Because the Disposition LSN refers to a specific grouping/category of non-NSN property, it has the effect of reducing the number of LSNs in the system and helps to keep like items grouped together under a common identifier instead of allowing for a proliferation of LSNs that, over time, would become unmanageable. Small Arms regulations require that systems use a LOGSA generated MCN for foreign captured or confiscated weapons to identify those weapons as they proceed through the system and to enable full tracking of these weapons in DOD and Component SA/LW Registries throughout processing.

**c. Describe Requested Change in Detail:** Both DSS and EBS shall carry and store the LOGSA generated MCN and a Disposition LSN specific to small arms, which will help to keep these items segregated from the regular Small Arms property. Component turn-in activities must send confiscated and foreign captured weapons immediately to destruction/demilitarization processing. Because of this, it provides no significant benefit to the enterprise to create a specific and separate materiel master for items that will only be received and subsequently destroyed. This change modifies DLMS transactions to allow for the inclusion of the Disposition LSN in addition to the LOGSA generated MCN. This ADC covers not only modification of the 527R for receiving but also the 511R, 846C, 846R, and the 947I to accommodate downstream processing of these items:

**527R (Materiel Receipt):** If a small arms item is receipted at a DLA Disposition Services Field Office, a 527R is sent to DLA Disposition Services. DLA Disposition Services will keep track

of the inventory at the serial number level. Therefore, the MCN and Disposition LSN are passed between both systems for accountability purposes.

**511R (Post-Post Requisition):** If a small arms item is to be demilitarized, a 511R identifying a post-post materiel release will be sent from the DLA Disposition Services Field Office to DLA Disposition Services to remove the small arms property from the record. Because DLA Disposition Services will need to track and update the inventory at the serial number level, the MCN and Disposition LSN must be passed on this transaction for accountability purposes. The residual scrap materiel is then received on the record via a scrap receipt based on dominant materiel content and processed via standard scrap procedures, where the MCN is no longer tracked.

**846C (Disposition Status Update):** If status updates are provided from the DLA Disposition Services Field Office to DLA Disposition Services (or vice versa), DLA Disposition Services will need to be able to keep track of the updates at the serial number level. Therefore, the MCN and Disposition LSN are passed between both systems for accountability purposes.

**846R (Inventory Reconciliation Management- daily and annual):** When inventory is performed daily or annually at a DLA Disposition Services Field Office, the 846R transaction is sent to DLA Disposition Services with updated inventory records. DLA Disposition Services will keep track of the inventory at the serial number level. Therefore, the MCN and Disposition LSN are passed between both systems for accountability purposes.

**947I (Inventory Adjustment):** If the quantity of a materiel on hand at a DLA Disposition Services Field Office needs to be adjusted for any approved reason, a 947I is sent with the updated quantity to DLA Disposition Services. DLA Disposition Services will keep track of the inventory at the original serial number level. Therefore, the MCN and Disposition LSN are passed between both systems for accountability purposes.

d. **Revisions to DOD 4000.25 Manuals:** None.

e. **Proposed Transaction Flow:** No new transactions or routing rules are required.

f. **Alternatives:** None available at this time.

**5. REASON FOR CHANGE:** Normally, the interchange of information between DSS and EBS for SA/LW transactions uses National Stock Numbers (NSNs). In the event that a weapon is confiscated from a civilian or captured from a foreign combatant, these weapons typically will not have an appropriate NSN to identify them. When this occurs, DOD SA/LW Serialization Program policy in DLM 4000.25, DLMS, Volume 2, Chapter 18, requires that the DOD Component obtain an MCN, or NSN if available, from DOD SA/LW Registry, to use to identify the weapon. Applicable DLMS excerpt below:

“C18.2.3. Small Arms and Light Weapons without a National Stock Number and/or Serial Number. When discovered, SA/LW without a National Stock Number (NSN) and/or SA/LW (except museum pieces) with missing, obliterated, mutilated, or illegible serial numbers shall be reported to the DoD Registry by the Component Registry for review and assignment of a Management Control Number (MCN)/NSN and/or serial number. Assignment of Local Control

Number (LCN) or MCN shall not replace or be used in lieu of procedures to request assignment of an NSN where applicable.”

Due to the large number of MCNs that are created for these purposes and the fact that these weapons are only allowed to be destroyed, it benefits DLA Disposition Services not to have to create a specific Materiel Master record for each of these MCNs. For the DLMS transactions, the DOD SA/LW Serialization Program authoritative MCN will be the primary materiel identification in the transactions; the DLA Disposition Services assigned Disposition LSN as a secondary reference. The SA/LW specific DLMS 140A (SA/LW Reporting) transaction must cite the DOD SA/LW Serialization Program authoritative MCN.

## **6. ADVANTAGES AND DISADVANTAGES:**

### **a. Advantages:**

(1) Proper inventory accountability records will be kept for SA/LW LOGSA generated MCNs and disposition LSNs, ensuring proper auditability of the records and maintaining consistency throughout data.

(2) Use of the Disposition LSNs will result in significantly less work required to create Materiel Master records that may only be used a few times.

**b. Disadvantages:** Updating these transactions may require coding changes in the RBI system suite to accommodate the field and values required to notate which NSN/LSN is which. Failure to accomplish these changes will result in significant coding changes being required.

## **7. ASSUMPTIONS USED OR WILL BE USED IN THE CHANGE OR NEW**

**DEVELOPMENT:** Confiscated and foreign captured weapons will only be turned in to the DLA Disposition Services Field Office that will demilitarize the weapons. If another DLA Disposition Services Field Office accepted the weapons and then shipped them to another DLA Disposition Field Office for demilitarization, the 856S and 945A would need to be modified as well to carry the Disposition LSN.
