

INTEGRATED COASTAL AND OCEAN OBSERVING SYSTEM (ICOOS) ACT OF 2009 IMPLEMENTATION PLAN

ACTIVITY: "[D]evelop and implement a process for the periodic review and evaluation of regional information coordination entities . . . [and] . . . develop and implement a process for the periodic review and evaluation of all non-federal assets, including regional information coordination entities."

ICOOS ACT REFERENCE: §12304 (c)(3)(E) and §12304 (c)(3)(H)

PLAN:

- Objectives/Milestones:
 - 1. Define and document procedures, including the frequency and standards, for periodic progress reviews for grants and co-operative agreements.
 - 2. Schedule annual program reviews beginning in Winter/Spring 2012.
 - **3.** Develop outcome metrics to evaluate regional information coordination entities.
- Execution Plan: Review and evaluate regional efforts through annual status assessments, regular reports on grant progress and expenditures, and administrative health assessments of grant recipients. Other actions that will contribute to the review and evaluation process include:
 - 1. Establish U.S. IOOS® <u>Regional Progress and Milestone Reporting Guidance</u> (completed) to cover:
 - Cooperative agreement semi-annual progress report requirements
 - Quarterly regional milestone reporting
 - Performance metrics reporting
 - Annual supplemental information to support program office needs
 - Annual project reviews
 - 2. Hold annual program reviews starting in FY12 (completed).
 - 3. Develop a national level metric to meet the Government Performance Results Act (GPRA) requirements. The GPRA metric will be supported by regional IOOS milestones and accomplishments. Staff from the U.S. IOOS Program Office will lead the effort to:
 - Draft a GPRA metric (Completed)

- Develop a business case for the GPRA metric that defines the terms and outlines reporting requirements (In progress)
- Circulate the draft GPRA metric and business case with regional partners (October 2012)
- Compile comments and make revisions to draft GPRA metric and business case (December 2012)
- Conduct a review of the draft GPRA metric by collecting and assessing the related metric data through a pilot project (March 2013)
- Finalize and submit the GPRA metric as part of NOAA's FY15 Budget Submission (May 2013)

The actions identified above will be used with the current on-going activities in the review process. Documentation of the process, frequency and standards will occur as part of this ICOOS Act Implementation Plan.
