New Vessel Monitoring System (VMS) Software Boatracs Users

Effective Date: November 1, 2012

On October 31st, Boatracs will automatically update the macros on your VMS unit to comply with recent Northeast regulatory changes. Make sure the new macros are installed on your VMS by following these steps: (1) Go to Macro #19 and make sure the top of the macro states "Vessel Activity Report V14.0"; and (2) Go to Macro #35 and make sure the top of the page shows "V9". If you do not receive the macro update, **please contact Boatracs at 1-800-262-8722.** Please be sure that your vessel's VMS unit has the new macros loaded, and begin using the new macros for trips on or after **November 1, 2012,** using the appropriate activity declaration.

Summary of Software Changes

NOTE: The numbering has changed for some macros (shown below); all other macro numbers remain the same.

- 1. <u>Multispecies Trips</u>: We separated the declaration into two separate screens, one for sectors (new **Macro 20**) and one for the common pool (new **Macro 21**). We also simplified the format and menu to make trip declarations easier. Lastly, the new **Macro 19** provides notes and information for macros 20 and 21.
- 2. <u>Monkfish Trips (new Macro 22)</u>. As we did with the multispecies menus, we simplified the format and menu to make it easier to declare your trip. The 'Notes' macro 19 also has a reference in this macro.
- 3. Scallop Trips (new Macro 23): The macro looks similar, but we have added new access area choices.
- 4. <u>Declare Out of Fishery (DOF)(Macro 24)</u>: To better identify trips that do not have specific VMS declaration requirements, we created the following five distinct DOF categories:
- A. Transiting
- B. Fishing commercially
- C. Fishing recreationally/charter
- D. Scientific research
- E. Participating in the Northwest Atlantic Fisheries Organization (NAFO) fishery.
- 5. <u>Trip Start Hail and Trip End Hail (Macro 36)</u>: As requested by many sectors, we added an optional 'Comments' field to the 'Trip Start Hail' and 'Trip End Hail.' Currently, only the Trip End Hail is required by NMFS for groundfish trips. However, some individual sectors require their members to use the Trip Start Hail. Complete the Trip Start Hail, if necessary, as instructed by your sector manager.
- 6. Restricted Gear Area Notification (Macro 37): We removed this form because the areas were eliminated.

Reminder of VMS Requirements

<u>Sector Vessel Owners/Operators</u>: If your sector is exempt from continuous VMS reporting at the dock, you are <u>required</u> to send the Power Down declaration (Macro 24) **prior** to powering off your VMS.

NOTE: You may <u>not</u> power off your VMS if you have other NE permits requiring continuous reporting.
