The TCPHS delivers specific training and practical guidance designed to encourage law enforcement practitioners to proactively implement community policing as a homeland security strategy. The course focuses on the systematic use of partnerships and problem-solving techniques, initiatives for building community resilience, grassroots intelligence gathering, and enforcement strategies that are likely to be effective means of interdicting terrorism. TCPHS) will include a comprehensive, blended-learning, national Instructor Development Program (IDP) that will provide law enforcement trainers with the knowledge, complete presentation materials, and supplemental resources needed to prepare local officers to effectively engage in homeland security activities, utilizing proven strategies, policies and operational procedures in a thriving community policing environment. The vision of the TCPHS program is to improve the capacity of law enforcement officers nationwide to fully and effectively integrate community policing into local, regional, and national homeland security duties, maximizing resources, building lasting partnerships, and enhancing public safety across the law enforcement agencies to partner with relevant stakeholders on homeland security initiatives and to integrate homeland security roles with community policing responsibilities.

Training Course: COPS Critical Incident Technical Assistance Initiative

Target Audience: Law Enforcement Agencies

Program Description: Law enforcement agencies are required to respond and provide support during a range of incidents, including those that might involve criminal activity, civil disturbances, and terrorism or high-profile issues. Each circumstance requires a specific response plan, resource pool, and collaboration of partners. In many cases, the immediacy of the incident precludes the responding law enforcement agency from conducting a comprehensive assessment of best practices to inform its response activities. This can cause mistakes, accidents, community hostility, media criticism, injuries, property damage, and cost overruns.

In addition, the range of potential incidents includes many that likely would overwhelm law enforcement agencies, particularly small to mid-sized agencies. In those cases, identifying and seamlessly engaging response partners can be a challenge while in the midst of a response. Often some agencies do not have the training and experience necessary to effectively execute a coordinated incident response. CNA will provide real-time training and technical assistance that incorporates community oriented policing principles in critical response operations.

Homicide Prevention Training

Course Description: Pharmaceutical drug abuse in Indian Country has grown to become a significant public safety issue that has contributed to the increase in violent crime rates in Indian Country, devastated Native American families, endangered children, and created a strain on the limited resources available to tribal law enforcement and service programs. In order to address this serious public safety concern, Lamar Associates, LLC (Lamar), and its project partners, the National Indian Child Welfare Association and the National Association of Drug Diversion Investigators have been funded to develop the Tribal Prescription Drug Endangered Children Training and Technical Assistance Program. Lamar and its partners will develop a training curricula and provide technical assistance that will: 1) increase the capacity of law enforcement agencies to serve the needs of drug endangered children and 2) increase the capacity of law enforcement agencies to build partnerships with public health, prevention, and treatment providers that will

lead to coordinated community responses to prevent prescription drug diversion and abuse. The training curriculum will be designed to acquaint the participants with: The Indian Child Welfare Act (25 U.S.C. 1901); civil and criminal jurisdiction in Indian Country; roles and responsibilities of service groups; types of reporting, cross-reporting, and information sharing; safety procedures for children, families, and responding personnel; accepted drug endangered children protocols; the national pharmaceutical drug assessments; the pharmaceutical impact in Indian Country including trends, signs of exposure in children, identification of drug user behavior and paraphernalia; identification drug contaminated environments; child risk assessment methodologies; community policing principles, problem-solving techniques, and strategic planning and collaboration with federal, state, private and tribal organizations.

Course Description: The goal of the training, *Public Safety De-Escalation Tactics for Military Veterans in Crisis*, is to build skills and capacity among public safety personnel to respond to military veterans (all branches), with a special awareness of those service members who have been deployed in their military career. 15 one-day regional instructor-led trainings will focus on awareness and tactics for public safety personnel who may encounter crisis situations that result from veteran re-integration. The training will include identification of mental illness and behavioral disorders, causal factors of military veteran stress-related conditions, converging conditions that may indicate higher risk for stress-related disorders (conditions that indicate high risk for stress-related disorders and difficulty adjusting to civilian life), officer safety principles to offset increased risk that may be encountered by public safety personnel negotiating or de-escalating crisis involving military veterans, and operational use of de-escalation techniques (based on case studies of successful applications).

SAI's innovative T/TA model promotes the role of indigenous leadership in building capacity to identify and implement best practices using community-policing principles in the 40+ COPS Tribal Meth Grantee sites to address methamphetamine trafficking and the effects of its use on tribal communities. The T/TA model creates a learning environment in which all participants (grantees, SAI, Tribal Fellows and other content experts) are listening, sharing, analyzing, and documenting key learnings from their work in addressing methamphetamine in Indian Country. Grantees receive training in the three pillars of community policing, how to develop their own needs assessments, mobilize key stakeholders and communities, and design a community-based participatory research model.
