Access

Scope and Content

The materials in FOIA 2006-0214-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

A White House Fellow during the Clinton Administration, Jamie Metzl held prominent positions with the National Security Council and the Department of State. He served as Director of Multilateral and Humanitarian Affairs at the NSC from 1997-1998 and in that capacity drafted Presidential Decision Directive PDD-68 on International Public Information (IPI). The *magna cum laude*, Phi Beta Kappa graduate of Brown University helped engineer IPI campaigns for Iraq and Kosovo in the course of his stay at the White House. While at the Department of State from 1998-2000, Metzl was Senior Coordinator for IPI. He currently is Executive Vice President of the Asia Society, an organization dedicated to creating an exemplary Pan-Asia-Pacific leadership development program.

FOIA request 2006-0214-F consists of emails, cables, memos, correspondence, and reports dealing primarily with Jamie Metzl's efforts to make IPI an integral part of NSC's goal to put the foreign policy of the United States in the best possible light all over the globe. The vast majority of records in this case are electronic in nature and show how Metzl made IPI his own private domain. However, worthwhile documents can be found in several different areas.

The White House Office of Records Management (WHORM) contains one relevant record. A number of papers describe how an article by Metzl entitled "Information Intervention: When Switching Channels Isn't Enough" was brought to the attention of President Clinton. Clinton sent a note to Metzl saying he enjoyed reading the piece.

The White House Staff and Office Files contain memos, forms, bills, and articles. These materials focus on Metzl's travels as a White House Fellow and his work on critical information infrastructure policy. In the end, what a researcher could find here would best be characterized as not substantive in nature.

Metzl was almost always a participant in these meetings. Although each conference comes with an extensive list of participants, the substance of the discussions receives scant mention.

The NSC Cable, Email, and Records Management Systems constitute by far the core of this collection. Metzl, who worked closely with Richard Clarke, is the center of attention in nearly all of the cables and emails. He surely must be viewed as the czar of IPI at the NSC. His hands are literally everywhere with respect to IPI—from the composition of PDD-68 to being a key player in campaigns aimed at the masses in Kosovo and Iraq.

System of Arrangement

Records that were responsive to this FOIA request were found in four collection areas—Clinton Presidential Records: WHORM Subject Files, Clinton Presidential Records: White House Staff and Office Files, Clinton Presidential Records: Automated Records Management System (ARMS) Emails, and Clinton Presidential Records: NSC Cable, Email, and Records Management Systems. As policy Staff and Office Files are processed at the folder level. That is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area. WHORM Subject Files are processed at the document level.

The WHORM Subject File was compiled by the White House Office of Records Management and is a series of categories designated by a letter/number combination. A complete listing of the categories with detailed descriptions is provided in our research room.

The Automated Records Management System (ARMS) Email is a database that contains email records of the Executive Office of the President. This system maintained unclassified Presidential record email. The ARMS dataset is comprised of 6 sub-series of email records called "Buckets." The buckets include NPR, OPD, POTUS, WHO, CEA, and Default. ARMS emails are arranged chronologically by creation date.
