Approximately 27 photographs, in color and black and white film processed from 35mm negatives.

#### Access

Collection is open to all researchers. The Clintons and Princess Margaret meet the Royal Ballet performers along with other staff and guests at the Kennedy Center.

**System of Arrangement**

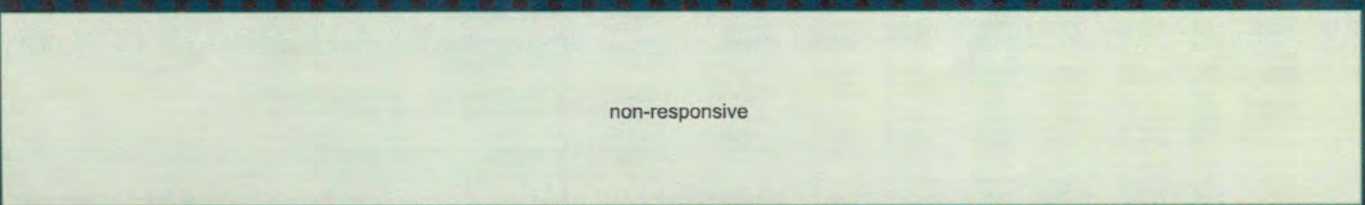
