## Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

## Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. #### **Provenance**

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

## **Scope and Content**

The materials in FOIA 2007-1452-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2007-1452-F contains records on an exchange of messages between President Clinton and Iranian President Khatami in August 1999. Since the U.S. government has no formal diplomatic relations with Iran, a third-party government served as an intermediary.

FOIA request 2007-1452-F consists entirely of electronic records in the form of emails. It should be noted that because of the sensitivity of these messages, the majority of this FOIA request is closed in full. The NSC Cable, Email, and Records Management Systems contain an email of a news report about the exchange of messages between governments and the role of the intermediary.

## **System of Arrangement**

Records responsive to this FOIA request were found in one collection area—Clinton Presidential Records: NSC Cable, Email, and Records Management Systems.
