Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Provenance

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

Scope and Content

The materials in FOIA 2008-0309-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

Proposition 209 is a California ballot proposition passed on November 5, 1996, which amended the California constitution to prohibit "preferential treatment to, any individual or group on the basis of race, sex, color, ethnicity, or national origin in the operation of public employment, public education, or public contracting." Since its passing, Prop 209 has been unsuccessfully challenged several times within state courts.

Clinton Presidential Records relating to Proposition 209 consist of WHORM Subject Files and White House Staff and Office Files.

White House Office of Records Management (WHORM) Subject Categories contain memoranda to the President.

The White House Staff and Office Files contain memoranda, legal briefs, correspondence, newspaper clippings, and articles relating to Proposition 209 and the lawsuits filed following its passing.

System of Arrangement

Records that were responsive to this FOIA request were found in two collection areas – Clinton Presidential Records: WHORM Subject Files and Clinton Presidential Records: White House Staff and Office Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject File was compiled by a letter/number combination.

Staff and Office files were maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

WHORM files are processed at the document level; whereas, Staff and Office files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
