# **Records concering Fritz Kraemer and Sven Kraemer.**

### Extent

4 folders, approximately 20 pages

## Access

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 2201) and the Freedom of Information Act (FOIA) (5 USC 552, as amended) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

## Copyright

Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

#### Provenance

Official records of William Jefferson Clinton's presidency are housed at the Clinton Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

#### **Scope and Content**

The materials in FOIA 2010-0173-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2010-0173-F contains records relating to Sven Kraemer. No records were found on his father, Fritz Kraemer. Sven Kraemer has a long career advising and making policy in the field of national security and defense. From the 1960s to the 1980s, he served in various positions at the Office of the Secretary of Defense, as a National Security Council (NSC) and U.S. Senate staffer and, later, as Director of Arms Control at the NSC during the Reagan administration.

FOIA request 2010-0173-F consists entirely of electronic records in the form of cables and emails. The NSC Automated Records Management System [Email] contains emails of WAVES appointments for upcoming vistors to the White House. The NSC Cable, Email, and Records Management Systems contains a cable on the restructuring of the OECD (Organization for Economic Cooperation and Development) Committee on Information, Computers and Communications Policy and an email regarding references on behalf of an NSC employee.

### System of Arrangement

Records responsive to this FOIA request were found in two collection areas— Clinton Presidential Records: ARMS Emails and Clinton Presidential Records: NSC Cable, Email, and Records Management Systems.
