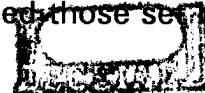
Dear Chairman Shields:

On October 5, 1992, we received the Second Amendment to the April 6, 1992, Agreement Between the Assiniboine and Sioux Tribes of the Fort Peck Reservation (Tribes) and the State of Montana (State) Concerning Video Keno, Poker and Bingo Games, Simulcast Racing and Other Class III Gaming. Accompanying the amendment is Resolution #1454-92-9 in which the Tribal Executive Board approves the amendment and authorizes the Chairman to sign the amendment.

The Compact between the Tribes and the State was approved on June 24, 1992, and the First Amendment was approved on September 1, 1992. Pursuant to Article VIII. B. of said compact, it is being further amended as follows:

1. In Article III, Sections A, B, and D, put a period in each Section after "slot machine," and strike "or a machine that directly dispenses coins, cash, tokens, or anything else of value."
2. In Article V, add a new Section E reading as follows:

"The Tribes may conduct live keno and live poker games 24 hours a day without limit as to the number of tables. The Tribes shall post the rules of play and maximum percentage rake-off in a prominent place in each establishment where such games are conducted. The prize limits for live keno games shall be the same as those provided in Section B 1 of this Article. Unless subsequently agreed upon otherwise, the prize limits for live poker games shall not exceed those set by the state for such games."



This amendment provides for the deletion of verbiage in Article III, Sections A, B, and D and adds a new Section E to Article V, relative to live keno and live poker, to the present compact. We do not believe the Amendment is contrary to the Indian Gaming Regulatory Act, Federal law, or violates the Federal trust responsibilities. Therefore, pursuant to 25 U.S.C. Section 2710, we approve the amendment as proposed.

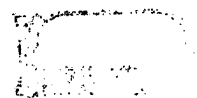

**AGENCY:** Bureau of Indian Affairs, Interior.

**ACTION:** Notice of approved amendment to Tribal-State Compact.

**SUMMARY:** Pursuant to 25 U.S.C. 2710, of the Indian Gaming Regulatory Act of 1988 (Pub. L. 100-497), the Secretary of the Interior shall publish, in the Federal Register, notice of approved Tribal-State Compacts for the purpose of engaging in Class III (casino) gambling on Indian reservations. The Assistant Secretary-Indian Affairs, Department of the Interior, through his delegated authority has approved the Second Amendment to the April 6, 1992, Agreement Between the Assiniboine and Sioux Tribes of the Fort Peck Reservation and the State of Montana Concerning Video Keno, Poker and Bingo Games, Simulcast Racing and Other Class III Gaming, which was approved on June 24, 1992, and first amended on September 1, 1992.

**SUPPLEMENTARY INFORMATION:** This is to give notice of a change to the Tribal-State Compact between the Assiniboine and Sioux Tribes of the Fort Peck Reservation and the State of Montana, which was published as a notice in the Federal Register in 57 FR 29408 on July 1, 1992. The compact has been amended to include "Lottery Games" and notice of the First Amendment was published in the Federal Register in 57 FR 41048 on September 8, 1992. The compact has been further amended to delete verbiage in Article III, Sections A, B, and D, as well as, include "live keno and live poker" as a new Section E to Article V.

This compact is amended as follows:

WHEREAS, the Fort Peck Tribal Executive Board is the duly elected body representing the Assiniboine and Sioux Tribes of the Fort Peck Reservation and is empowered to act on behalf of the Tribes. All actions shall be adherent to provisions set forth in the 1960 Constitution and By-Laws, and

WHEREAS, the Tribes and State of Montana have negotiated a Compact concerning class III Gaming under the Indian Gaming Regulatory Act, and

WHEREAS, the Tribes and State of Montana desires a second Amendment to the Gaming Compact as follows:


1. In Art III, Sections A,B, and D, put a period in each Section after "slot machine", and strike "or a machine that directly dispenses coins, cash, tokens or anything else of value".
2. In Art V, add a new Section E reading as follows:  
"The Tribes may conduct live Keno and live poker games 24 hours a day without limit as to the number of tables. The Tribes shall post the rules of play and maximum percentage rake-off in a prominent place in each establishment where such games are conducted. The prize limits for live Keno games shall be the same as those provided in Section B1 of this Article. Unless subsequently agreed upon otherwise, the prize limits for live poker games shall not exceed those set by the State for such games."

THEREFORE, BE IT RESOLVED that the Tribal Executive Board hereby approves the attached Second Amendment to the April 6, 1992 Gaming Compact between the Assiniboine and Sioux Tribes and the State of Montana.


BE IT FURTHER RESOLVED that the Tribal Chairman is authorized to sign the Second Amendment to the Compact.


C E R T I F I C A T I O N
